B/292 The Honourable First Member for Curepipe and Midlands (**Mr Guimbeau**)

To ask Dr the Honourable Minister of Agro Industry and Fisheries:-

Whether he will state if cane planters are categorized according to the extent of land they cultivate and, if so, will he state the different categories thereof, indicating the acreage of land in each case?

DRAFT REPLY

Mr Speaker, Sir,

In the Sugar Industry Efficiency Act 2001, the Cane Planters and Millers Arbitration and Control Board Act, the Sugar Industry Labour Welfare Fund Act, and the Sugar Insurance Fund Act, "Planter" means any person, or group of persons, growing sugar cane in one or more factory areas and includes any person, acting as manager for that person or group of persons.

As per **Mauritius Sugar Syndicate Act,** planter means the owner of a sugar cane plantation and includes the owner of a sugar factory.

The **Mauritius Sugar Authority** defines a planter as a planter cultivating over 100 arpents in sugar cane.

I am informed by the Sugar Insurance Fund Board (SIFB) that under section 2 of the Small Planters Welfare Fund Act, "small planter" is defined as:

"a planter who is registered with the Fund as a planter growing sugarcane, tea, tobacco or food-crops, including fruit and ornamentals, on his land or on leased land, on an extent not exceeding 10 hectares".

Based on the above definition, SIFB categorizes sugar cane planters may be categorized as small or large. The data provided in respect of crop 2006 is as follows:-

Since the SIFB has the most reliable data in respect of sugar cane planters, most of the measures designed for planters are based on the data provided by the SIFB.

For the Regrouping project, the MSA has adopted the following definition:-

On the other hand, FSC which has a mandate to devise and implement schemes and programmes with a view to enhancing the productivity and efficiency of planters adopts the following definitions:-
