MERCHANT SHIPPING NOTICE Ref: 1 of 2018

Title: Sea service remission for PSCRB Course

Notice to: Maritime Training Institutions, Seafarers Recruitment and Placement Service Provider / Ship operators/ Ship Owners

The objective of this Merchant Shipping Notice is to provide instructions to all those concerned on review of the admission criteria for the Proficiency in Survival Craft and Rescue Boats (Other than Fast Rescue Boats) course following several requests received from Maritime Training Institutions and Seafarers Recruitment and Placement Service Provider

- 1. Following the huge demand for seafarers to join the cruise industry (e.g. cruise ships); the Director of Shipping has received several requests regarding the review in the rules for admission to the PSCRB (other than fast rescue boats) course.
- **2.** For obvious reasons new seafarers do not possess the required sea-service of either 6 months plus training or 12 months as stated in STCW Regulations VI/2.
- **3.** According to various recruitment agencies, ship owners/operators are requiring all new crew members to follow the PSCRB Course prior joining the ship.
- **4.** In order not to jeopardise the opportunities that are being offered to Mauritians, the Director of Shipping has considered the case and come up with a solution that would ease up the problem.
- **5.** As from 09 May 2018 and until further notice, any seafarer having successfully completed the four elements of Basic Safety Training (BST) may be admitted to the PSCRB (other than fast rescue boats) as follows:
 - **a.** Attend the full course at an approved Maritime Training Institution (while being medically fit). *No assessment would be required at that time.*

- b. After completion of the course, the Maritime Training Institution shall issue to the trainee an "Attestation" (*Model as at Annex A*) to the effect that the course has been attended.
- **c.** Once in possession of the document as in (b) above, the seafarer shall proceed on-board and complete a minimum of six (6) months of sea-service as required.
- **d.** Upon his/her return to Mauritius, the seafarer shall sit for the required examination at the respective Maritime Training Institution and upon being successful, will be issued with a "*Certificate of Proficiency*" in "*Proficiency in Survival Craft and Rescue Boats (Other than Fast Rescue Boat)*".
- **e.** All Maritime Training Institutions adopting this system shall forward the lists of their trainees undergoing this training to the Ministry.
- f. Prior embarking on requirement 5(d) above, any seafarer shall have his/her sea-service duly assessed by the Director of Shipping and be given the required authorisation to sit for the examination.
