#### Title: PUBLICATIONS REQUIRED ON MAURITIUS REGISTERED VESSELS

Notice to Ship Owners, Operators, Agents, Masters & Recognized Organisations

**APPLICABLE TO:** All vessels registered under the Merchant Shipping Act 2007 and subject to SOLAS 74 as amended

ENTRY INTO FORCE: DATE OF THE PRESENT NOTICE TO MARINERS

The following publications must be carried onboard every Mauritius vessel subject to SOLAS 74 as amended.
