To ask Dr the Honourable Minister of Agro Industry and Fisheries:-

Whether, in regard to State land leased for agricultural and non-agricultural purposes in the region of La Vigie, he will give a list of the beneficiaries, indicating in each case the extent of the land leased?

Mr. Speaker, Sir,

In the region of La Vigie, according to records available at my Ministry, there are 25 lessees of State land for agricultural purposes at Diore, Devoyenne, Malherbes and Wooton.
