Vacancy for the Post of Second-Hand Fishing (Limited)

Applications are invited from qualified candidates who wish to be considered for appointment as Second-Hand Fishing (Limited) in the Ministry of Ocean Economy, Marine Resources, Fisheries and Shipping.

II. AGE LIMIT

Candidates should not have reached their $\underline{48}^{th}$ birthday by the closing date for the submission of applications.

III. QUALIFICATIONS

- A. A Certificate of Competency as Second-Hand Fishing (Limited) issued under Section 38 of the Merchant Shipping Act 1986 (as amended).
- B. At least three years' experience in the operation of fishing boats or other boats at sea.

Candidates should produce written evidence of experience claimed.

IV. DUTIES AND SALARY

- 1. To be responsible to the Skipper or any other senior officer for the following duties -
 - (i) to carry out proper co-ordination and execution of fishing operations;
 - (ii) to operate fishing, patrol, research and training boats with inboard or outboard motors;
 - (iii) to ensure the general maintenance of boats and their equipment and the safe keeping of stores items;
 - (iv) to take part in the preparation of fishing operations;
 - (v) to assist in the preparation and setting of fish aggregating devices at sea:
 - (vi) to take part in any Search and Rescue Operations and in landing operations on any islet in the waters of Mauritius; and
 - (vii) to perform such duties as may be assigned during dry docking of boats/vessels.

2. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Second-Hand Fishing (Limited) in the roles ascribed to him.

The permanent and pensionable post carries salary in the scale of Rs $16,400 \times 325 - 17,700 \times 375 - 19,575 \times 475 - 21,950 \times 625 - 23,200 \times 775 - 27,075$ a month plus salary compensation at the approved rate.

Selected candidate will in the first instance be appointed in a temporary capacity of six months with salary at the flat rate of Rs16,400 a month plus salary compensation at the approved rate.

V. MODE OF APPLICATION
